A NEW ROADWAY PROJECT WILL BEGIN IN YOUR AREA

OVERVIEW

On Monday April 1, 2013, the Florida Department of Transportation (FDOT) is scheduled to begin a roadway construction project along State Road (SR) 907/Alton Road from 5 Street to Michigan Avenue in the City of Miami Beach.

PROJECT SCHEDULE

April 1, 2013 — summer 2015

WORK TO BE PERFORMED

- Installing three pump stations (at 5 Street, 10 Street and 14 Street) and a new drainage system to improve storm water drainage in area
- Rebuilding roadway, driveways, sidewalk and pedestrian ramps
- Constructing sidewalk extensions, which will remove about 90 on-street parking spaces
- Constructing concrete islands in the median to manage left turn movements at 9 Street, 13 Street, 14 Street, 14 Court and 15 Terrace and along Alton Road from 16 Street to Lincoln Road
- Modifying the median opening at Alton Road and 6
 Street to prevent motorists travelling east on 6 Street to turn north on Alton Road
- Upgrading the traffic barrier on Alton Road flyover and Dade Canal
- Replacing traffic and pedestrian signals at intersections
- Installing new street lighting
- Installing new landscaping and irrigation
- Installing new signage and pavement markings

LANE CLOSURE & DETOUR INFORMATION

To do this work safely, it will be necessary to close travel lanes and conduct detours at times. Permanent work zones, which will shift the existing travel lanes, will be established to lessen the effects of construction. Throughout the project, portions of Alton Road will be converted into a northbound-only roadway, providing two northbound travel lanes and areas of on-street parking, when possible. Southbound traffic will be encouraged to use West Avenue. Pedestrian access will be maintained through protected sidewalk paths around the construction. Lane closure, detours and project information will be posted weekly on the Department's website.

HELPFUL TIPS

- Allow extra time to reach your destination
- Obey all posted signs and speed limits

ALWAYS PUT SAFETY FIRST

For your safety and the safety of others, please use caution when driving, walking or biking around any construction zone. Wearing a safety belt is the single most effective way to protect people and reduce fatalities in motor vehicle crashes. The department takes steps to reduce construction effects, but you might experience the following around the work site.

- Travel lane closures and detours
- Periodic closures of on-street parking
- Increased dust and noise
- Workers and equipment moving around the area

Please note that this schedule could change due to bad weather or other unexpected conditions.
